

# iPad Q & A

What if I leave early? Where will I take my iPad?

If you leave early, bring your iPad by the media center. We will take your iPad and give you a yellow iPad exit slip to show at the front desk. We will return your iPad to your homeroom class at the end of the day. If you are in your homeroom class when you leave, your teacher will give you an iPad exit slip.

# iPad Q & A

What if something is not working right on my iPad?

Your teacher will try to troubleshoot first. If not successful, the teacher will call 2506 for instructions.

# iPad Q & A

What if I must leave my iPad in the media center because it is not working? How will I do my work?

You will always leave the media center with a SICK IPAD pass that is date and timestamped to show your teachers that your iPad is in for repair. We will accommodate you with computers and laptops until another iPad can be setup.

# iPad Q & A

What if I break my iPad screen?

You should report the breakage to your teacher immediately. The teacher will send you to the media center!!! Parents must be notified as soon as possible. You will be given a BROKEN IPAD pass to keep inside the back of your iPad case. If a teacher asks you if you reported the damage, you can show them the BROKEN IPAD pass.

# iPad Q & A

What will happen if I change the lock screen or remove my assigned passcode lock?

The passcode and lock screen photo are there to protect your data and help identify your iPad. Disciplinary action will be taken if either are changed after today.

# iPad Q & A

What are the rules about downloading apps?

School owned iPads should not be synced to any other computer or personal device. Apps should be downloaded by students only at the request of teachers or administrators. **Apps may ONLY be downloaded from the HCS APPS app container...no other way!!** Students may not download from the Apple APP STORE.

# iPad Q & A

What is V-Share? I heard my friends talking about downloading apps using V-Share.

V-Share is illegal!!! Disciplinary action will be taken for any student who uses V-Share or any other pirating app service that downloads apps onto your school device.

# iPad Q & A

Is it okay for me to video or take a photo of someone else?

You may not photograph or video someone without their permission. It is a violation of Horry County Schools policy. Be aware that state and federal laws prohibit secret recording undertaken without the knowledge and consent of the person or persons being recorded. Violations of state and federal recording laws may be reported to the proper authorities and may result in criminal prosecution.

# iPad Q & A

Will our iPads be inspected?

School personnel may randomly select students and ask them to share their iPad for inspection.

# iPad Q & A

May we send emails during class without teacher permission?

The answer is NO! Email is available for educational purposes only. Please note that administration has access to all of your emails at any time, and administration has the right to read them at any time. If you send emails that are not related to your current academic class, it is considered off task behavior and disciplinary action can be taken.

# iPad Q & A

What if I lose my iPad at school?

Report it to your teacher immediately.

# iPad Q & A

May we use our iPads in the halls between classes?

No. Electronic devices, earbuds and earphones should be secured and out of sight during transitions.

# iPad Q & A

Is it okay for me to hold my friend's iPad while he/she goes to the restroom?

No. Students should not touch, carry, etc. another student's iPad.

# iPad Q & A

Some of my friends are creating folders inside of folders inside of folders. Can we do that?

It is okay to make folders, but please do not make a folder within a folder. It can cause technical problems with your iPad and cause it to freeze.
